Message from the CBDCE Chair

2022 CBDCE Chair



We are well into the second half of 2022 with the uncertainties of the COVID-19 pandemic still affecting our personal and professional lives. I'm impressed with the resilience and creativity of our certificants and other healthcare providers as we all

continue to meet the needs of people affected by diabetes despite the challenges.

I've been reflecting on people who have influenced my career path and ultimately my choice to become a Certified Diabetes Care and Education Specialist® (CDCES®). One of my biggest influences came from some kind and patient diabetes educators who helped me as a rebellious and angry teenager diagnosed with type 1 diabetes. Besides giving me information/education, they helped me develop important problem-solving skills and confidence while offering non-judgmental support and encouragement. As I entered college and eventually a dietetics program, they developed into mentors and motivators, inspiring me to eventually finish my training as a registered dietitian and ultimately earn the CDCES (then CDE) credential. I wanted to have a positive impact on the lives of others who are affected by diabetes. I continue to be inspired by those with diabetes and their families/caregivers that I work with daily. I am also inspired by my fellow CDCESs and other health care professionals that work to help all affected by diabetes live their best lives.

I bet that many of you have memories and stories of those who have influenced, mentored, and supported you on your journey so far. There are others that continue to fuel your passion for helping those affected by diabetes. I am encouraging all of our certificants to consider their role as an inspiration to those you serve as well as the value of mentorship in strengthening our profession.

Here are some ideas to consider:

- 1) Assist persons with diabetes and their families/caregivers in finding ways to help others affected by diabetes as they are able to.
- 2) Work with students in health-care professions to have a more balanced and compassionate view of diabetes

management. Encourage them to consider certification in their futures.

- 3) Sign up as a mentor for future CDCESs through the Mentorship Program. There are many potential CDCESs that have challenges getting the experience needed to apply for initial certification. You could be the missing link to help someone move forward in their career. Look at it as investing in your own future—supporting quality diabetes care and education for when you're ready to retire or move on to your next challenge. We know the need is out there to help people at risk for or living with diabetes who do not have access to a diabetes care and education specialist, let alone one who is certified.
- 4) If you are in a leadership role, consider helping to develop future leaders through mentorship activities and encouraging your peers to consider volunteer service.
- 5) Consider volunteering on a committee or leadership position in your state or national professional organizations. Reach out to CBDCE to discuss possible volunteer experiences that might be a good fit for you within the committees that support our certification activities.

I am so honored to be the chair of the CBDCE Board of Directors for 2022. I appreciate all of those who have mentored, inspired, and even pushed me to do better and for those of you who continue to do so. Oprah Winfrey stated, "A mentor is someone who allows you to see the hope inside of yourself." If you are not already involved in these types of activities, I challenge you to consider taking the next step to help strengthen our community as Certified Diabetes Care and Education Specialists.

Q & A Corner

Q: What is the CDCES Renewal Audit Policy?

A: CBDCE conducts random audits on a regular basis and also reserves the right to verify and/or audit at any time any application is submitted for certification. CDCESs whose applications are selected for audit must provide verification that they met all the requirements at the time of application. Verifications include licensure/registration, practice hours, as well as documentation of completion, e.g., a photocopy of the certificate of completion, verification of attendance, brochure, or other relevant material, for all continuing education activities submitted. If you are chosen for audit, you will be notified via email and must provide required documentation by the deadline date identified in the audit notice. The deadline date is approximately 14 days after submitting the application. The exact deadline and a link to the required documentation will be provided in the email notice. IMPORTANT: A late fee of \$25 will be assessed for the review of audit documentation not received by the deadline date identified in the audit notice.
