
Congratulations! Newly Certified CDCESs

The 2022 CDCES Scholarship program application window is open now through May 15, 2022. The program supports the journey for health professionals in the specialty and to encourage diversity in the pool of the health professionals holding the Certified Diabetes Care and Education Specialist (CDCES) credential. Individuals chosen as scholarship recipients are provided with an opportunity to take the practice examination at no cost and apply for the Certification Examination for Diabetes Care and Education Specialists one time at no cost! Individuals have 2 years from the date of the award to make use of the award and will

need to document meeting all current eligibility requirements for initial certification at the time of application for the Examination. The value of each scholarship is \$405. Be sure to let your colleagues know about the scholarship program and encourage them to apply!

Q: Do I need a minimum of 200 practice hours each year?

A: No. There is no minimum number of hours for the renewal practice requirement needed every year, only the need to be able to attest to having obtained the minimum 1000 practice hours within the accrual cycle (and before applying for renewal). Learn more about <u>renewal</u>.
