## **CDCES and BC-ADM Credentials**

Health professionals across various disciplines often ask about the differences between the two credentials and whether obtaining the BC-ADM would be a good fit for them as a CDCES. We have outlined a helpful side-by-side comparison of the two credentials. Many holding the BC-ADM are also CDCESs, and they find value in both credentials within their specific role. BC-ADM credentialed professionals have demonstrated expertise in advanced diabetes management and passed a rigorous exam. Within their scope of practice, they adjust medications, treat and monitor acute/chronic complications, provide lifestyle modification counseling, address psychosocial issues, and participate in research and mentoring.

### **CBDCE Portal**

If you haven't logged into your CBDCE portal within the last year, you will need to reset your password.

#### To log in to reset your password on your CDCES account:

- 1. Go to www.cbdce.org > click on Sign In
- 2. Enter your email address of record as your username. If you don't recall what email address is on record, please email the CBDCE team with your name and the month/day of your birthday or CDCES number at info@cbdce.org. You may also use the contact form.
- 3. Select CONTINUE
- 4. Click on Forgot Password > then enter your username again > follow the instructions.
- 5. You will receive an email to reset your password. If you do not see the reset email in your inbox, please check your spam/junk folder.

\*VERY IMPORTANT NOTE: If the system does not recognize the email address you entered as your

username, it likely means we have a different one on record. In this case, don't create a new record—please contact info@cbdce.org. Creating a new record will NOT allow you to connect to current certification information and/or history. It will make it difficult for you to access your current record to recertify promptly and will require extra steps/time for you and the CBDCE team to straighten out a situation where you end up with multiple records. If any of your contact information has changed, make sure you update it in your CDCES record.


